- **Introduction:**

This policy outlines the usage and publishing guidelines when accessing the Stardom University website www.stardomuniversity.edu.eu and other sub-sites owned and operated by the university. Please read this privacy policy and terms of use carefully before starting to use the website.

Your access to and use of the website is conditioned on your acceptance of and compliance with this privacy policy and terms of use. These policies and terms apply to all visitors and users who use the university's website. If you do not agree with this policy and the terms of use, please do not use the website.

Stardom University reserves the right, at its sole discretion, to change this policy and terms of use at any time when necessary or in case of breach of the website's content publishing and management policies without the need for notification. The university also reserves the right to restrict access to any part of or the entire website without prior notice.

Stardom University implements a comprehensive and strict information security policy. Only authorized employees are allowed access to personally identifiable information, and they have committed to securing the confidentiality of this information in accordance with applicable regulations.

Stardom University reserves the right to take all necessary measures to protect against any loss or misuse of the website or the information contained therein. The university is not legally responsible for any damage that may be incurred by any party or website user due to their violation of the policy and terms of use. Section 2: Acceptable Use Terms

By accessing and using the university's website, you agree to and commit to the following:

- Not committing any illegal acts.

- Using Stardom University's website for work purposes only.
- Not downloading non-work-related media, such as:

- Not using technologies that bypass proxies or firewalls to access the internet.

- Not framing, squeezing back, overlaying, or using other techniques to insert or display the website, or any trademark, logo, content, or other proprietary information.
- Not using any meta tags or any other "hidden text" using Stardom University's names or trademarks without prior written consent.
- Not using any device or software that interferes with the normal functioning of the website.
